Share Options

On 11 June 2008, the Chief Executive Officer of the Company proposed to grant options to four executive directors and eight senior executives to subscribe for a total of 19,032,000 ordinary share of US\$0.02 each in the capital of the Company. This proposal was adopted by the Remuneration Committee and options granted were accepted by the participants in June 2008. The option will be exercisable at S\$0.07 per share with an exercise period commencing from 11 June 2009 to 10 June 2013 (both days inclusive). During the quarter ended 31 March 2012, 1,464,000 unexercised share options were lapsed on the ground that the employee left the Group. 1,464,000 share options were exercised in each of the quarters ended 30 September 2012 and 31 March 2013, and further 13,176,000 share options were exercised in the quarter ended 30 June 2013 under the Company's Employee Share Option Scheme. 1,464,000 unexercised share options were lapsed and cancelled on 10 June 2013 at the expiry of the share options.

Income Statement

During the first nine months of current year under review ("9M14"), the Group recorded a decrease of US\$20.2 million in revenue to US\$106.9 million as compared to the revenue of US\$127.1 million in the corresponding period in the previous financial year 2013 ("9M13"). The Group's gross profit for 9M14 reduced by US\$5.1 million or 18.0% to US\$23.2 million from US\$28.3 for 9M13. The gross profit margin also fell to 21.7% in 9M14 as compared to 22.3% in 9M2013. The reasons for the decrease in revenue and the gross profit margin were stated below.

Other income included the gain on redemption of available-for-sale investments amounting to US\$0.4 million. Distribution expenses for 9M14 fell by 26.6% to US\$1.7 million (9M13: US\$2.3 million). The decrease was in line with the decline in the Group's revenue. Attributable to the closure of operation in Suzhou and cost

control measure, administrative expenses were trimmed by US\$2.9 million to US\$16.4 million in 9M14 (9M13: US\$19.3 million). Finance cost was US\$0.1 million in 9M14 and remained at a low level under the Group's low gearing policy. Income tax expense was reduced by US\$1.0 million to US\$1.8 million over 9M14 (9M13: US\$2.8 million). In the absence of gain on bargain purchase recorded in 9M13, and with the drop in revenue. The Group's pre-tax profit and after-tax profit dropped by US\$4.2 million and US\$3.2 for 9M14 to US\$7.0 million (9M13: US\$11.2 million) and US\$5.2 million (9M13: US\$8.4 million).

LCD Backlight Units

LCD Backlight Units segment's sales, comprising more than half of the Group's sales, was down by 20.1% to US\$69.6 million in 9M14 (9M13: US\$87.1 million). Orders from customer dropped as a result of the termination of some old products in gameset and a shortage of a key part for ultra-thin backlight unit due to production difficulty. In order to ensure a stable supply of this key part, the Group intends to invest in a supplier by means of equity investment to expand the supplier's production capacity which is solely for the Group's production need. During 9M14, the Group sold 6.0 million backlight units for handsets (9M13: 6.1 million) and 12.0 million backlight units for gamesets (9M13: 22.7 million).

During 9M14, the Group sold more bigger size LCD backlight units which are with higher proportion of material costs and this product mix subdued the profit margin. As such, the Group recorded an operating profit of US\$7.2 million (9M13:US\$11.4 million) at an operating margin of 10.4% (9M13: 13.1%), representing a 2.7% decline in operating margin.

Office Automation

Sales in the Office Automation segment were affected by weak demand in Japan and the PRC. In 9M14, it recorded a slight decrease in revenue by US\$0.1 million to US\$17.0 million (9M13: US\$17.1 million). With agreement with customers to cease production of loss-making parts, this segment recorded an operating profit of US\$0.1 million (9M13: Operating loss of US\$0.3 million) and at an improved operating margin of 0.4% (9M13: Negative margin of 1.6%).

LCD Parts and Accessories

There was a drop in revenue of LCD Parts and Accessories segment by US\$2.4 million to US\$20.4 million in 9M14 (9M13: US\$22.8 million). The segment recorded an operating profit of US\$0.9 million (9M13: US\$0.1 million) at an operating margin of 4.2% (9M13: 0.3%). The improvement in performance was mainly due to the introduction of new products for smart phones during the period under review.

Statement of Financial Position

Total assets and liabilities as at 30 September 2014 stood at US\$108.8 million (31 December 2013: US\$109.8 million) and US\$41.4 million (31 December 2013: US\$40.8 million) respectively.

Total current assets rose by US\$1.2 million over 9M14 to US\$98.2 million as at 30 September 2014 (31 December 2013: US\$97.0 million). The increase in cash and bank balances was associated with the excessive cash released from the reduction in the Group's working capital and the increase in the net proceeds of bank loans. Inventories remained at a reasonable level with sufficient quantity to fulfill customer orders. In line with the decline in revenue, the trade receivables decreased by US\$6.2 million over 9M14 to US\$19.0 million as at 30 September 2014. There is no material change in the credit terms to customers in general. Other receivables mainly represented utility deposits, prepaid expenses, value-added tax recoverable and advances to a research and development project as a new business to the Group. Included in loans and receivables is the loan to third party for generating higher interest income.

Total non-current assets as at 30 September 2014 stood at US\$10.7 million (31 December 2013: US\$12.8 million). Included in property, plant and equipment was the newly purchased equipment amounting to US\$0.4 million, which was netted off against the depreciation charge of US\$1.4 million for 9M14. Also, with the redemption of an investment, the available-for-sale investments dropped by US\$0.9 million over 9M14 to US\$0.1 million as at 30 September 2014.

Total liabilities as at 30 September 2014 were up to US\$41.4 million, representing an increase of US\$0.6 million over 9M14 (31 December 2013: US\$40.8 million). During 9M14, the Group redrew new bank loans and other borrowings amounting to US\$16.1 million while settled bank loans and other borrowings amounting to US\$11.0 million. The total amount of bank and other borrowings were increased by US\$5.0 million to US\$11.6 million as at 30 September 2014. In order to take the advantage of low interest environment, the new bank loans are of long-term nature and at fixed interest rate.

The trade payable was reduced by US\$3.0 million over 9M14 to US\$20.5 million as at 30 September 2014 (31 December 2013: US\$23.5 million). It was consistent with the decline in revenue as explained above. There was no material change in the credit terms offered by the Group's suppliers.

The income tax on profit for 9M14 was provided and adjusted under tax rules of different jurisdiction.

Included in the non-current liabilities are retirement benefit obligation for directors in the Group's subsidiaries in Japan and deferred tax liabilities.

Statement of Cash Flows

The Group generated net cash from operating activities amounting to US\$7.0 million for 9M14 (9M13: net cash used in operating activities amounting to US\$14.9 million). The improvement in net cash from operating activities was mainly attributable to the decrease in working capital associated with the revenue at low level for 9M14.

For investing activities, there was a net cash inflow of US\$2.0 million over 9M2014 (9M13: US\$9.1 million). The net cash from investing activities were mainly attributable to the receipt from the redemption of available-for-sale investments and receipt of interest income. During 9M14, the Group purchased property, plant and equipment amounting to US\$0.4 million (9M13: US\$1.0 million).

For financing activities, there was a net cash outflow of US\$0.8 million over 9M14 (9M13: US\$7.9 million). The financing activities mainly included the net proceeds of bank loans amounting to US\$5.1 million during 9M14 (9M13: Net repayment of bank loans of US\$2.7 million) and the payment of FY2013 final dividends of US\$3.3 million and FY2014 interim dividends of US\$2.4 million.

Business Environment

The industry in which the Group is operating is highly competitive. As the Group's production facilities are located in the PRC, the Group is facing persistent inflation and increasing labour cost associated with tightening labour supply. These unfavourable effects have outweighed the productivity gain from Management's deployment of more efficient production equipment and processes.

In the first half of the current financial year ("FY2014"), the Group experienced a general slowdown in customer orders. Even though Management has secured orders of new models of ultra-thin backlight units from customers in the second half of FY2014, the production has been seriously affected by the shortage of a key part due to production difficulty.

Business segment outlook

The LCD Backlight Units segment suffers from slowdown in sales orders of phased-out old models. It is the market trend that LCD backlight units for smart phones and tablets will dominate this segment. Such bigger size of LCD backlight units, albeit with higher average selling price, would lead to a lower profit margin compared to small size LCD backlight units as bigger size LCD backlight units require a higher proportion of materials. This trend is expected to persist in the foreseeable future. Volume orders of new models have been secured for the second half of FY2014, and Management continues to explore new customers in the PRC. For ultra-thin backlight units, the shortage of a key part due to production difficulty has affected the production and reduced the sales to the Group's key customer. In order to secure a stable supply of this key part, Management is negotiating an equity investment in a supplier to expand its production capacity with output solely for the Group's use. This investment will be approximately US\$2.5 million, and the supply of the key part will pick up as soon as the facilities are installed.

Contending against the weak and sluggish demand in the LCD Parts and Accessories, Management has secured orders of parts for tablets and super-thin, lightweight notebooks which maintain the segment's profitability.

The Office Automation segment managed to have new orders for new products, along with eliminating the loss-making products and increasing selling price of existing products to the Group's customers, gradually improving performance.

Managing risks

Frequent release of new models or introduction of new products in advance of other players is a competitive advantage in the consumer electronic industry. As such, Management takes the benefit of the Group's research and development capability to meet the demand of customers, particularly new customers in the PRC, to shorten the development cycle for new models or products. This effort is to diversify the Group's customer base in the consumer electronic industry as well as in other industries which require the Group's technical and production know-how, since Management views the high reliance on a key customer to be the major risk of the Group.

For the Group's core business, Management continues to focus on its profitability through minimising operating expenses by regular reviews of operating costs, production process re-engineering and active inventory management. For any non-core business, Management actively explores investment opportunities in new business segments with stable income and business growth in order to improve the earning quality.
